Information to our providers

«Firmanavn» has signed a contract as a provider of distribution services with Adressa Distribusjon AS. This document is an elaboration of the administrative routines Adressa Distribusjon AS is expecting to be followed.

1) Deadline for submission of invoice:

Invoice must be sent with a 10 days due date. This means an invoice with due date (payment date) set to the first date of the month (e.g. 01.02.2016), must be sent to the company the latest at 22.01.2016 (example).

2) Which points should the invoice include:

Adressa Distribusjon AS cannot pay an invoice where VAT is billed if «Firmanavn» is not registered in the VAT register. Furthermore, Adressa Distribusjon AS cannot pay an invoice where VAT is not billed, if «Firmanavn» total turnover has passed NOK 50 000,-. Registration can be made via Altinn (www.altinn.no). Your local tax office can also assist you in the proses.

The letters **VAT/MVA** shall be inserted after the organization number on the invoice, as soon as «Firmanavn» has received a confirmation of the completed registry in the VAT register.

What will be invoiced (see example in the enclosed invoice):

- **Monthly sum** (fixed yearly sum, divided by 12), period specified (e.g. 01.11.15-30.11.15).
- Waiting (due to production / printing problems) rate is supplied in the contract. Latency is a subject of control, and the distribution manager shall be notified by email/telephone every day.
- Media post books, billed at NOK 2, apiece.
- Media post magazines, billed at 0, 50, apiece.
- Attachments/advertisement distribution:
 20-60 grams: Billed at NOK 0,40,- apiece.
 61-100 grams: Billed at NOK 0,50,- apiece.
 101-200 grams: Billed at NOK 0,70,- apiece.
 Byavisa/free newspapers: Billed at NOK 0,65,- apiece.

For rates mentioned above «Firmanavn» feel free to contact us if you lack an overview of distributed items of any period.
